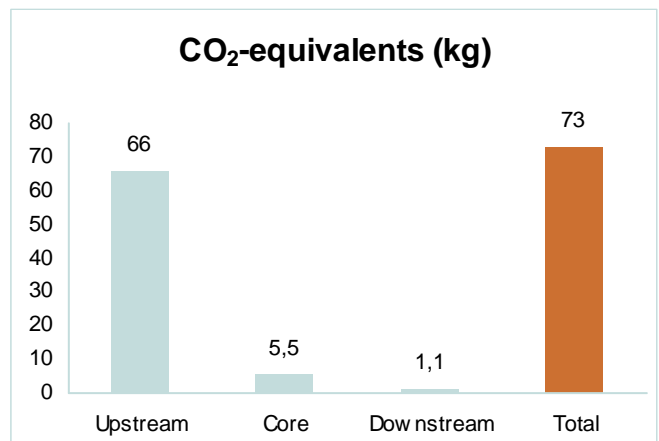
## Climate declaration

The study includes production of materials and parts, assembly, transport to retail and use phase. Transportation between the processes and packaging production are included as well. The studied system also includes waste from the different life cycle phases.

The results are presented for the following modules: the upstream module includes production of raw materials, main parts and components, the core module includes all production and assembly

processes and the downstream module includes transport to the customer. No relevant environmental impact occurs during the use of the product. Recycling of the product is not included.

The result is presented for one chair including production and use during 15 years.
